The personal data processing policy establishes the principles of personal data processing processed by the public institution Pro Partners, the rights of data subjects and other relevant issues in the process of personal data processing.

The policy has been developed in accordance with the 2016 April 27 Regulation (EU) No 182/2011 of the European Parliament and of the Council 2016/679 (hereinafter - the General Data Protection Regulation or the Regulation), the Law on Legal Protection of Personal Data of the Republic of Lithuania (ADTAJ), the Labor Code of the Republic of Lithuania and other legal acts regulating personal data protection.

Registration for and participation in the International Nechama Lifshitz vocal competition

We would like to inform you (hereinafter also referred to as “participant”) that upon submission of the registration for the International Nechama Lifshitz vocal competition (hereinafter also referred to as “competition”) together with further attachments, the Public Institution Pro partners will process the personal data collected from you there (e.g. surname, first name, title, photograph, address, email address, curriculum vitae, name of the university, name of the teachers, nationality, competition program, bank details or payment information, if applicable) for the purposes of registration for the competition, payment of the participation fee, participant administration, implementation and organization of the competition and transmission of information on the competition to the participant.

Furthermore, parts of the collected data as well as the placement in the competition will be printed in the program booklet and published on the competition homepage for the purpose of informing the public, the interested public and the jury about the performing artists. This also includes the information of the press. The competition will also be transmitted via live stream on the Internet.

The names, address, curriculum vitae and the competition program are mandatory information required for the execution of the participation contract. Participation in the competition is not possible without this information. The other data collected and all other additional data provided are voluntary. By submitting the registration form together with any additional attachments, you expressly consent to their processing for the above-mentioned purposes.

For the purpose of direct marketing (so that we can inform you about the provided services, promotions and special offers, ask for opinions about organized events, etc. electronically, by phone, registered and ordinary mail) we process name, address, telephone number, e-mail address, workplace. We will process your e-mail contact details for direct marketing purposes without separate consent, in accordance with Paragraph 2 of Article 69 of the Law on Electronic Communications of the Republic of Lithuania. You may revoke your consent to the processing of your personal data for direct marketing purposes at any time by contacting us by email. email info@propartners.lt

Recipients of personal data

A transmission of parts of the data to the International Nechama Lifshitz vocal competition foundation takes place within the framework of the service agreement concluded between the International Nechama Lifshitz vocal competition foundation and Pro partners.

Personal data will also be transmitted to the jury. Furthermore, personal data will be transmitted to the audience, the press and technical service providers for the realization of the live streaming. This serves the implementation of the competition and thus the participation or is in any case in the legitimate interest of the organizers in the external impact of the competition .

Duration of the storage

The personal data collected is stored in printed documents and in our information systems. We protect your personal data to the extent required by law or for the purposes of data processing if they provide for a longer retention period. Personal data is generally stored for as long as reasonable claims can arise from the contractual relationship. Unnecessary personal data is destroyed.

In addition, we retain information so that we can provide you with the information we need to have a proper history of our relationship with you and answer any questions you may have about our relationship.

Respecting your time, we process your personal data, which we process with your consent for direct marketing purposes, until you withdraw your consent to the processing of your personal data.

At the end of the time limits, the data are deleted in such a way that they cannot be restored or transferred to the state archives, if such an obligation is imposed on us by legal acts.

Prize winners of 1st to 6th place will be listed on the homepage for a period of up to one year by name and a photograph. The legal basis for this is the legitimate interest of the organizers in informing the interested public about the prize winners.

Communication with us

Processed data and purposes of processing

When contacting Pro partners by email, the data you provide (your email address, your name and your telephone number, if applicable) will be stored by us in order to answer your questions or process your other requests.

Duration of storage

The data is deleted as soon as it is no longer necessary for the purpose for which it was collected, i.e. when the respective conversation has ended and provided that there is no obligation to retain it. The conversation ends when it is clear from the circumstances that the matter in question has been finally clarified.

What rights do you have?

In accordance with the procedure established by legal acts, data subjects must:

- Know (be informed) about the processing of your data (right to know);
- Access to your data and how it is processed (right of access);
- Require the rectification or, depending on the purposes of the processing of personal data, the addition of incomplete personal data (right of rectification);
- Destroy your data or suspend your data processing (excluding storage) (right to destroy and right to be "forgotten");
- Has the right to demand to restrict the processing of personal data (right to restrict);
- Has the right to transfer data (right to transfer);
- The right to have personal data deleted ("right to be forgotten");
- The right to withdraw consent to the processing of personal data. Withdrawal of consent shall not affect the processing of data prior to the withdrawal;
- Do not consent to the processing of personal data when such data are processed or are intended to be processed for the purposes of direct marketing, including profiling in so far as it relates to such direct marketing.

Upon receipt of a complaint, request, request or instruction, no later than within one month from the date of the request, the public institution Pro partners shall submit a response and perform the actions specified in the request. If necessary, this period may be extended by a further two months, depending on the complexity and number of applications. In that case, within one month from the date of receipt of the request, the Data Subject shall be informed of such extension, together with the reasons for the delay.

What cookies and how do we use it?

Cookies are text files stored in the browser of the user's device when you browse the website www.competition.lt and contain information about browsing. Cookies allow the website to "remember" your actions and choices for a period of time, and you do not have to re-enter them each time you visit the website or browse its various pages.

The first time you visit the Website, cookies are transferred to the user's device and then used to identify the device. We do not use cookie-related information to identify you.
